(hereafter "buyer"), for the purpose of setting forth the terms and conditions of the purchase by Buyer of a purebred male/male ____ from the litter welped on _____(date), out of litter number

Sale is contingent upon your veterinarian's approval within 5 working days after receiving the dog. Seller guarantees that the dog is in good health and has received appropriate vaccinations for destemper (DA2P+PV) and Parvo.

If the dog is unsatisfactory and is to be returned to Seller, it must be done within the time limit of 2 weeks from the date the dog was delivered to Buyer. The dog is to be returned to Seller at Buyer's expense and must be in the same physical condition as when it left Seller.

The Buyer and Seller agree to a one year (from the date of purchase) warranty against veterinarian confirmed congenital defects. However, if the buyer will purchase the NuVet Supplement and give it to the puppy as a part of his/her daily diet this guarantee will be extended to three years with the continual use of the NuVet Supplement during that time.

Seller will not pay for any veterinarian expenses that Buyer may incur. Determination of what constitutes a congenital defect is to be made by the unanimous agreement of two veterinarians agreeable to both parties. If a problem develops that is proven to be the Seller's responsibility, the Seller will replace the dog. Replacement will be made at the earliest possible availability of a replacement dog. Replacement will be made as per equal quality and same sex. In case of death, an autopsy must be obtained at the Buyer's expense within 24 hours of death to establish cause.

In connection with the above warranties, buyer hereby expressly agrees that under no circumstances shall the seller's liability to buyer exceed the purchase price paid for the puppy nor shall the seller be liable for consequential damages of any sort including veterinary examination and treatment.

The provisions of this warranty shall be interpreted and construed in accordance with the laws and statues of the State of Iowa. The venue for any litigation concerning the warranty will be limited to Davis County, Iowa under a non-jury proceeding.

The intent of this contract is to provide Buyer with a quality pet with no guarantee of show quality. No warranties other than those stated have been given or implied. By my signature I affirm that I have read, discussed, and understood the terms and conditions of this agreement.
